# **WORK UPDATE**

- After removing the windows on the 5th floor, we are now installing windows on the 4th floor.
- Temporary weather screens have been installed on the 5th floor.
- Roof coverings on the two main roofs, East and West, are now completed.
- Water has found its way through to the top floor and temporary repairs are underway to address the issue and prevent it from happening again.
- We are expecting to hand back floors 3 & 4 in the coming weeks.
- Cladding work has started and progressing well.
- The sub-structure for the cladding is now at floor 9, with siderise cavity barriers and Rockwall installation fitted up to level 3.
- Residents on the ground and first-floor flats have returned to their homes, while the second-floor is scheduled to return from week commencing 29 July.

#### LOOK AHEAD

- Kitchen and bathroom suites are expected to be fitted in the coming weeks following the completion of the first fix of electrics and plumbing on floor 4.
- Return of floor 3 residents, will start next week.
