MORE4MK SUPPLIER EVENT

Ibbie Omideyi (Social Impact Manager) and Lee Wrycraft (Quantity Surveyor), and a group of subcontractors (ROSS, BaileyMK and JBHopkins) presented at a Milton Keynes City Council-led suppliers event for local small to medium construction-related businesses. 72 companies registered, learning more about construction projects being delivered in the city, including our Lakes Estate Renewal Project, and how best to access open packages. The event allowed us to create a directory of around 20 contacts with whom we will invite to tender for upcoming packages, invite to join a local supply chain network/GRAHAM framework so they can access other projects, and will provide additional support/mentoring for micro businesses.

SITE	UPDATE	LOOKING AHEAD
Windermere Drive A1	Completion of piling and completion of concrete reinforced foundations. Progression of precast concrete columns.	First floor slab work commencement on 11A. 11B ground floor slab work ongoing.
Windermere Drive A3	Completion of walls up to first floor brickwork. Curb installation to south elevation to site. Progression of first to second floor brick work.	Completion of second floor brick work. Roof truss installation.
Melfort Drive	Plots 1A/B brickwork up to first floor complete. Precast floor planks installation ongoing. Continuation of foundations, drainage and external brickwork.	Additional piling complete and foundations ongoing to 2A and 3A. Precast slabs and masonry ongoing.
Burnmoor Close	Installation of precast planks and blockwork up to first floor.	Ground floor precast complete to block 1. All precast complete and roof trusses commenced on block 2.
Drayton Road	Progression of internal, storm and foul water drainage. Blockwork up to first floor ongoing.	Additional piling complete. Ground floor precast slabs ongoing.
